## 1. Out of Bounds

- All areas marked with white stakes.
- The clubhouse

A ball coming to rest inside the boundary of a residential property **is out of bounds** and **MUST NOT BE RETREIVED**. Any player or caddie trespassing on Residential Properties may be liable to prosecution.

## 2. Water Hazards and Lateral Water Hazards

- These are indicated by **Yellow** and **Red** stakes.  
Hazard stakes are **movable** obstructions.

## 3. Obstructions

- Stones in bunkers are movable obstructions (Rule 24-1 applies)
- Steps in bunkers are immovable obstructions. Relief is allowed under (Rule 24-2)
- Immovable obstructions close to putting green.

If a ball lies through the green and an immovable obstruction on or within two club-lengths of the putting green and within two club lengths of the ball interferes on the line of play between the ball and the hole the player may take relief as per (Rule 24-1)

- All paths are immovable obstructions and relief is allowed under (Rule 24-2)
- e. Young trees and their irrigation bowl marked with blue stakes.  
If such a tree or irrigation bowl interferes with a player's stance or his intended swing, the ball **MUST** be lifted without penalty, and dropped in accordance of Rule 24-2b.

**4. If a ball strikes an elevated power line** or cable, the stroke **MUST** immediately be replayed without penalty. This includes the pylon and elevated section rising from the ground. If ball is not immediately recoverable, another ball may be substitute.

## 5. Abnormal ground conditions

- These are indicated with white lines, GUR, or may be casual water.
- Burrowing animal, reptile, or bird – **A PLAYERS STANCE IS EXCLUDED**

Relief may be taken from these conditions in accordance with (Rule 25-1b) without a penalty.

## 6. Embedded Ball

Through the green, a ball that is embedded in its own pitch mark in the ground may be lifted without penalty, cleaned and dropped as near as possible to where it lay but not nearer the hole. The ball dropped must first strike a part of the course through the green.

## 7. Pine Needles: Finely Mulched Bark

These are considered an integral part of the course and **NO RELIEF** may be taken.

## 8. Preferred Lies:

**Please see outside notice board if preferred lies are applicable.**

A ball lying on the fairway in play may be lifted without penalty and cleaned. Before lifting the ball, the player **must mark its position**. Having lifted the ball, he **must place it** on a spot within (as specified on the outside notice board) of and not nearer the **hole** than where it originally lay, that is not in a **hazard** and not on a **putting green**.

A player may place his ball only once, and it is **in play** when it has been placed (Rule **20-4**). If the ball fails to come to rest on the spot on which it was placed, Rule **20-3d** applies. If the ball when placed comes to rest on the spot on which it is placed and it subsequently **moves**, there is no penalty and the ball must be played as it lies, unless the provisions of any other **Rule** apply.

If the player fails to mark the position of the ball before lifting it, moves the ball-marker prior to putting the ball back into play or moves the ball in any other manner, **such as rolling it with a club, he incurs a penalty of one stroke**.

## 9. Distance Measuring Device

A player may obtain distance information by using a device that measures distance only.

## 10. 9<sup>th</sup> and 18<sup>th</sup> Dam wall.

The Dam wall on the 9<sup>th</sup> and 18<sup>th</sup> is considered dangerous, loose, hanging rocks which may give in if under pressure. no golfer is allowed to step on dam wall or fines will be issued.
