Caddies

*Caddies are for your own account. Please note Caddies are on a first come first serve basis and we regrettably **cannot** make reservations for services that we **cannot** guarantee. Should your clients have a special request for Caddies we as a club will endeavour to do everything possible to have them present, however they are self employed and in so doing beholden to themselves only.*

Winelands Venue:

The Winelands venue closes at 12am (midnight). The final round of drinks will be called at 10pm, Should you require that we stay open later please see the associated costs:

- Midnight onwards – **R2500.00** per hour or part thereof until 2am when the venue will close. This is subject to an increase from 01 August 2014.

Watering Hole Conditions

- All food or beverage arrangements must be approved well in advance and purchased from Boschenmeer. A maximum of 4 wet holes is allowed.
 - Food and Beverage may only be supplied by yourselves if it is on a 1:1 basis or if you pay the whole corkage fee of R100 [alcohol rules still apply].

- We refrain from having huge amounts of alcohol on a golf course. Beer and hard liquor are allowed at halfway, before or after golf. On course, we allow shooters and tastings of alcoholic products.
- Sponsors must please supply their own equipment, e.g. tables, chairs, umbrellas.
- Ice is limited on golf days. Please arrange and order well in advance.
- Representatives of your company or the sponsor must be stationed at the wet holes to man them.
- Your company representative will receive the stock and sign for it upon receipt. Stock will be charged on consumption to the master account or sponsor.
- In order to ensure that drinks are kept as cold as possible, the drinks will only be sent out 30 minutes before the first golfers will reach the first watering hole.

Sponsors/Branding/Activities

- In order to ensure that the clients are serviced all people who need to be on the course must arrive no later than 8am in winter and 9am in summer.
- The same applies to banners. People who require help getting equipment etc on course need to arrive at the times as indicated above.
- No Food Products may be prepared on the golf course, Braai etc, only by prior arrangement with the caterers
- Tables, chairs, ice etc must be brought in by the client.
- It is extremely difficult to get private vehicles on the course as our golf bridges were not built for cars and they may not take such weight.
- The staff will be unable to help once the field starts to go off.
- Car companies displaying vehicles at the club.
 - 1st Tee in summer can be used for car displays; however the risk of the car being hit with a golf ball from the chipping greens and from the 9th is very real. No cars can be displayed in winter in these areas, as the area is too wet.
 - The Putting green can be used to display cars (three max) can be put in this area.
 - One car can be positioned in front of the halfway house next to the pond.
 - The 10th tee has space for three cars; this area can be used summer or winter.
 - The 19th tee has space for one car; this is the area on the cart path just short of the tee box.
 - No other areas are allocated for vehicles.
- Putting competitions may not take place on the golf course. This slows down play and creates a negative image for the club. Slow play is the Bane of all courses and we want people's experiences here to be a positive one.
- Putting competitions will only take place in front of the clubhouse.
- No rings will be sprayed on the greens for betting (wager) holes.
- We have sufficient markers for four nearest the pins and two longest drives, or any combination of the six.

Banners:

Only "A" frame banners allowed.

Should you wish the golf course to set up your branding for you a detailed plan of the branding is required 48 hours prior to the event. The club accepts no responsibility for damages made to branding and accepts no responsibility for incorrectly erected branding.

Caddies:

No outside caddies will be permitted on the Estate.

Golf Carts:

No outside golf carts will be permitted on the Estate.

Course:

Watering of Greens daily especially in summer months: am + pm. Please be advised.
(Sprinklers & Hand Watering)

Security Gate:

A full list of participating players' names will be required 24 hours prior to play. ID Document or Drivers License required and they will scan once and Driver of Vehicle goes through. A matter of a few seconds. Please just advise all players on day.

Housing Estate:

Please also note that the housing estate is considered out of bounds and golf balls may not be retrieved from private property.

Booking Confirmation

All golf day bookings at the Paarl Golf Club, will be required to pay a non-refundable deposit of R 5000 (R2500 for schools & charities) to confirm their booking. Whether or not such loss, damage or injury is occasioned by any act or omission of the Club, the Board or its Employees, or anyone else for who's actions they, or any of them would be liable in law or by reason of vis major, casus fortuitus, rain, or other water, riots, strikes, theft, burglary (with or without forcible entry) or by reason of any condition on or off the golf course, or any facility of the Club, or caused by any sporting or other activity carried on, on the property of the Club or by any other cause of whatsoever nature and howsoever arising.

Rain Policy

Paarl Golf Club reserves the sole right to close the course due to extreme weather conditions or when the course become unplayable (as decided by the club). In such circumstances, the Club will consider a partial refund of moneys. Weather will not indicate cancellation of other functions. (Extreme conditions include inter alia rain, thunder and lightning.)

Cancellation Policy

Golf

Golf days that are cancelled in 7 days or less from the reserved date, will be charged in full. Players that are booked for the day and that are not cancelled at least 48 hours prior will be charged in full. Golf carts that are reserved and that are not cancelled 24 hours prior will be charged in full. No refunds will be given on the day. Full payment of green fees must be made 14 days prior.

Conferences

Paarl Golf Club shall not be held responsible for any interruptions of services (water, electricity, sanitary services). We draw your attention to our Disclaimer Conditions.

Weddings

Paarl Golf Club shall not be held responsible for any interruptions of services (water, electricity, sanitary services). We draw your attention to our Disclaimer Conditions.
